- Assist in developing and maintaining standard/emergency operating procedures for all
 processes related to the operation of the City of Leduc and the Capital Region Southwest Water
 Services Commission's water systems and wastewater collection system
- Troubleshoot, repair and maintain storm and sanitary laterals; investigate, repair and maintain all storm/wastewater mains; operation and maintenance of lift stations; perform water quality testing and analysis.

- Testing, operation and maintenance of fire hydrants
